Welcome to the latest issue of SRA Update. It's September, the start of autumn, and that always marks the beginning of a busy period for legal services. The legal year starts on 1 October, and our practising renewal period gets under way the same day. We will be contacting you next week as part of that process, and we include some information in this issue on what you should do to prepare. Also this month, we have produced new guidance on how we will deal with sexual misconduct - which we continue to get reports on - and we've updated our guidance on acting with integrity. And we are consulting on the details of refinements to our fining regime, so please share your views.

The Legal Services Board has agreed the level of individual practising fees for 2022/23. They will increase from £266 to £286. Individual compensation fund contributions will fall from £40 to £30. Firm fees vary as they are linked to turnover.

## **First ever SQE2 results published**
