## Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

The [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.

The **Fund** [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) is a discretionary fund of last resort and no **person** [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) has a right to a grant enforceable at law.

3. The primary objects of the **Fund** [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) are:
  1. to replace money which a **defaulting practitioner**

### **Rule 3: Grants which may be made from the Fund**

#### 3. For any grant to be made out of the [Fund](#)

[<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Fund>], an [applicant](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant>] must satisfy the [SRA](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] that the [applicant](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant>] is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:

1. loss in consequence of the dishonesty of a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] or the employee or [manager](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#manager>] or [owner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#owner>] of a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>]; or
2. loss and hardship in consequence of a failure to account for money which has come into the hands of a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] or the employee or [manager](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#manager>] or [owner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#owner>] of a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>], which may include the failure by a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] to complete work for which the [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] was paid, in the course of an activity of a kind which is part of the usual business of a [defaulting practitioner](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>] and, in the case of a [defaulting licensed body](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner>], the act or default arose in the course of performance of an activity regulated by the [SRA](#) [<https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA>] in accordance with the terms of the body's licence.

#### 3. For the purposes of rule 3.1(b):



1. an individual whose dealings have been in a personal capacity with the [defaulting practitioner](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
2. a body corporate, or an individual whose dealings have been in a business capacity with the [defaulting practitioner](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.

4.   2. at the time the application is made, is a sole trader, [partnership](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#partnership) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#partnership\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#partnership), body corporate, unincorporated association or mutual association with an annual [turnover](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#turnover\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) of less than £2 million, and does not fall within rule 4.2, 4.3(a) or 4.4(a).
5. A [person](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant in the circumstances set out in rule 3.1(a) if at the time the application is made the [person](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) falls within one or more of the following categories:

5. ## **Rule 5: Defaulting practitioners**

The SRA may only make a grant in respect of acts or omissions of a [defaulting practitioner](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner], or of a [defaulting practitioner's](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] employee, [owner](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#owner) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#owner] or [manager](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#manager] as appropriate, which fall within rule 3.

  1. a [solicitor](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor] or an [REL](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#REL) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#REL] who at the date of the relevant act or omission was:
    1. practising in an [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]; or

An [applicant](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must make an application for a grant in the [prescribed](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed) form, and within 12 months of the date they first became aware, or should reasonably have become aware, of the loss.

Failure to provide such documentation or to co-operate with the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) will be taken into account when determining the merits of the application.

The [SRA \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may not make a grant unless it has given not less than 8 days' notice to the [defaulting practitioner \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) informing them of the nature and value of the application, unless it appears to the [SRA \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that it would not be reasonably practicable to give such notice, or the grant should be made urgently.

Where the [SRA \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) makes a grant otherwise than by way of loan or if by way of loan repayments of the loan is waived or otherwise the borrower has failed to repay part or all of the loan, the [SRA \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall be subrogated to the rights and remedies of the [person \[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#person) to whom or on whose behalf the grant is made to the extent of the amount of the grant.

If the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) refuses to make a grant of either the whole or part of the amount applied for, the [applicant](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) will be informed in writing of the reasons for the decision.
