2. An [authorised body](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) carrying on a [practice](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice) during any [indemnity period](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period) beginning on or after 25 November 2019 must take out and maintain [qualifying insurance](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) under these rules with a [participating insurer](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer).
3. In respect of its obligation under rule 2.1, an [authorised body](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body)



must obtain a [policy](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy) of [qualifying insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) prior to the expiry of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period), that provides cover incepting on and with effect from the expiry of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period).

4. If the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) has been unable to comply with rule 2.2, the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) must obtain a [policy](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy) of [qualifying insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) during or prior to the expiry of the [extended policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period) that provides cover incepting on and with effect from the expiry of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period).
5. If the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) has been unable to comply with either rule 2.2 or rule 2.3, the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) must cease [practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice) promptly, and by no later than the expiry of the [cessation period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period), unless the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) obtains a [policy](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy) of [qualifying insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) during or prior to the expiry of the [cessation period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period) that provides cover incepting on and with effect from the expiry of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period) and covers all activities in connection with [private legal practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#private-legal-practice) carried out by the [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) including, without limitation, any carried out in breach of rule 4.2.

3. Notwithstanding rule 2.1 above, an [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) must take out and maintain professional indemnity insurance that



provides adequate and appropriate cover in respect of current or past practice taking into account any alternative arrangements the body or its [clients](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client) may make.

4. An [authorised body](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) must ensure that its [clients](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#client) have the benefit of the indemnity insurance required under these rules and must not exclude or attempt to exclude liability below the minimum level of cover required under these rules.

Rule 9: Details of participating insurer

There must be no monetary limit on the cover for [defence costs](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs).

4. Proportionate limit on defence costs

Notwithstanding clauses 2.1 and 2.2, the insurance may provide that liability for [defence costs](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) in relation to a [claim](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) which exceeds the [sum insured](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured) is limited to the proportion that the [sum insured](#) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured)



[regulations/glossary/#sum-insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#sum-insured)] bears to the total amount paid or payable to dispose of the [claim](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim).

5. **No other limit**

The insurance must not limit liability to any monetary amount (whether by way of an aggregate limit or otherwise) except as contemplated by clauses 2.1 to 2.3 (inclusive).

6. **One claim**

The insurance may provide that, when considering what may be regarded as one [claim](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) for the purposes of the limits contemplated by clauses 2.1 to 2.3 (inclusive):

1. all [claims](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) against any one or more [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) arising from:
 1. one act or omission;
 2. one series of related acts or omissions;
 3. the same act or omission, in a series of related matters or transactions;
 4. similar acts or omissions, in a series of related matters or transactions, and

7. **Multiple underwriters**

2.6.1 The insurance may be underwritten by more than one [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer), each of which must be a [participating insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer), provided that the insurance is fully underwritten.

2.6.2 Where the insurance is underwritten jointly by more than one [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer), the insurance:

1. must state which [participating insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer) shall be the [lead insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#lead-insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#lead-insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#lead-insurer);

The insurance may be subject to an [excess](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) of such monetary amount and on such terms as the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) and the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) agree. 4. The insurance must provide that the [excess](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) deductible does not reduce the limit of liability contemplated by clause 2.1.
5. The [excess](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) must not apply to [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs).

7. The insurance may provide for multiple [claims](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim] to be treated as one [claim](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim] for the purposes of an [excess](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#excess] contemplated by clause 3.1 on such terms as the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] agree.

4. Special conditions

4. No avoidance or repudiation

The insurance must provide that the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not entitled to avoid or repudiate the insurance on any grounds whatsoever including, without limitation, any breach of the duty to make a fair presentation of the risk, or any misrepresentation, in each case whether fraudulent or not.

4. No adjustment or denial

The insurance must provide that the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not entitled to reduce or deny its liability under the insurance on any grounds whatsoever including, without limitation, any breach of any term or condition of the insurance, except to the extent that one of the exclusions contemplated by clause 6 applies.

5. No cancellation

The insurance must provide that it cannot be cancelled except (in the case of (a), (b) or (c) below) by the agreement of both the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer], and in any event only in circumstances where:

1. the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] is merged into a [successor practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], provided that there is insurance complying with these [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] in relation to that [successor practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice)

2. replacement insurance, complying with the [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) in effect at its commencement, commences, in which case cancellation shall have effect no earlier than the date on which such replacement insurance commences; or

Cancellation must not affect the rights and obligations of the parties accrued under the insurance prior to the date from which cancellation has effect.

6. **No set off**

7. **No 'other insurance' provision**

The insurance must not provide that the liability of the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) is reduced or excluded by reason of the existence or availability of any



other insurance other than: (i) as contemplated by clause 6.1; or (ii) where the [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured], having entered the [extended policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period] or [cessation period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period], obtains a [policy](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy] of [qualifying insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#qualifying-insurance] that incept from and with effect from the expiration of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period]. For the avoidance of doubt and subject to the provisions of the [participating insurer's agreement](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer-s-agreement) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer-s-agreement], this requirement is not intended to affect any right of the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] to claim contribution from any other [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] which is also liable to indemnify any [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured].

8. No retroactive date

The insurance must not exclude or limit the liability of the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] in respect of [claims](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim] arising from incidents, occurrences, facts, matters, acts and/or omissions which occurred prior to a specified date.

9. Successor practice - 'double insurance'

The insurance may provide that, if the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm-s-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm-s-practice] is succeeded during the [period of insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance] and, as a result, a situation of 'double insurance' exists between two or more [insurers](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurers) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurers] of the [successor practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice], contribution between [insurers](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurers) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurers] is to be determined in accordance with the relative numbers of [principals](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#principals) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#principal] of the owners of the constituent [practices](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practices) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice] immediately prior to succession.

10. Resolution of disputes as to insurer of successor practice

The insurance must provide that, if there is a dispute as to whether a [practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice] is a [successor practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice] for the purposes of clauses 1.1 or 5.5, the [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured] and the



[insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will take all reasonable steps (including, if appropriate, referring the dispute to arbitration) to resolve the dispute in conjunction with any related dispute between any other party which has insurance complying with these [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] and that party's [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer].

.8A Conduct of a claim pending dispute resolution

The insurance must provide that, pending resolution of any coverage dispute and without prejudice to any issue in dispute, the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will, if so directed by the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA], conduct any claim, advance [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] and, if appropriate, compromise and pay the claim. If the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] is satisfied that:

4. the party requesting the direction has taken all reasonable steps to resolve the dispute with the other party/ies;
5. there is a reasonable prospect that the coverage dispute will be resolved or determined in the [insured's](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured] favour; and
6. it is fair and equitable in all the circumstances for such direction to be given,

it may in its absolute discretion make such a direction.

4. Advancement of defence costs

The insurance must provide that the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] will meet [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] as and when they are incurred, including [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] incurred on behalf of an [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured] who is alleged to have committed or condoned dishonesty or a fraudulent act or omission, provided that the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] is not liable for [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs] incurred on behalf of that [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured] after the earlier of:

1. that [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured] admitting to the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] the



commission or condoning of such dishonesty, act or omission;
or

2. a court or other judicial body finding that that [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) was in fact guilty of such dishonesty, act or omission.

5. Variation of insurance terms

The terms of the insurance must provide that the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) shall vary the terms of the insurance to give effect to any variation to the SRA Indemnity Insurance Rules, the Glossary and the [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC), such variation to be implemented by the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer):

1. on the date of any renewal or replacement of the insurance or any extension to the [period of insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance) occurring in that [indemnity period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period); or

save that no variation shall be required under clause 4.10(b) where the date on which variation would have been required is a date within the [extended policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period) or the [cessation period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period).

6. MTC to prevail

The insurance must provide that:

2. any provision which is inconsistent with these [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) (including any amendment pursuant to clause 4.10) is to be severed or rectified to comply.

5. Extended policy period and run-off cover

6. **Cessation period**

7. **Run-off cover**

Subject to clause 5.7 the insurance must provide run-off cover:

1. in the event of a [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation] that occurs during or on expiration of the [policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy-period];
2. in the event of a [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation] that occurs during the [extended policy period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#extended-policy-period] or the [cessation period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation-period]; or

8. **Scope of run-off cover**

The run-off cover referred to in clause 5.3 must:

2. provide a minimum level of insurance cover in accordance with clauses 2.1 and 2.3;
3. be subject to the exclusions and conditions of the insurance applicable in accordance with the [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC]; and



4. extend the [period of insurance](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-insurance)

9. **Succession**

The insurance must provide that, if there is a [successor practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#successor-practice) to the ceased [practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice), the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) may elect before its [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation), whether it wishes the ceased [practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#practice):

If the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) fails to make an election and/or fails to pay any premium due under the terms of the [policy](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#policy), before its [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation), clause 5.5(b) above shall apply.

10. **Suspended practices**

The insurance must provide that, where run-off cover has been activated in accordance with this clause 5, but where the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm-s-practice) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm-s-practice\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm-s-practice) restarts, the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) may (but shall not be obliged to) cancel such run-off cover, on such terms as may be agreed, provided that:

1. there is insurance complying with these [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) in



relation to that [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] in force on the date of cancellation;

2. the [participating insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#participating-insurer] providing such insurance confirms in writing to the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] and the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] (if different) that:
 1. it is providing insurance complying with these [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC] in relation to that [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] for the then current [indemnity period](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#indemnity-period]; and
 2. it is doing so on the basis that the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] is regarded as being a continuation of the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice] prior to [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation] and that accordingly it is liable for [claims](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim] against the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm] arising from incidents, occurrences, facts, matters, acts and/or omissions which occurred prior to [cessation](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#cessation].

11. **Transfer to another approved regulator**

6. Exclusions

The insurance must not exclude or limit the liability of the [insurer](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insurer] except to the extent that any [claim](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim) [https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#claim] or related [defence costs](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#defence-costs)

6. Prior cover

7. Death or bodily injury

Any liability of any [insured](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured) for causing or contributing to death or bodily injury, except that the insurance must nonetheless cover liability for psychological injury or emotional distress which arises from a breach of duty in the performance of (or failure to perform) legal work.

8. Property damage

11. **Debts, trading liabilities and funding arrangements**

Any:

1. one or more of the [principals](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#principal) of an [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) are [RELS](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#REL) who claim that professional indemnity insurance, or a professional indemnity fund, under their home professional rules provides the [insured firm's practice](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm's-practice) with professional indemnity cover in all respects equivalent in its conditions and extent to that which would be provided under the [MTC](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#MTC). (Full Home State Cover);
2. no more than 25% of the [principals](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#principal) of the [insured firm](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#insured-firm) are [solicitors](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor); and
3. the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) is so satisfied, (including, without limitation, by reason of any provider of the Full Home State Cover entering into such agreement as the [SRA](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) may require from time to time),

The period of insurance must not expire prior to the date with effect on which the [Partial Home State Cover](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover) expires or is avoided.
4. The following clause shall be added:
 1. **6.12 Partial Home State Cover**
 2. The insurance may exclude any liability of the insurer to the extent that any such liability is covered under the terms of the [Partial Home State Cover](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover) [\[https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover\]](https://qltt.sra.org.uk/solicitors/standards-regulations/glossary/#Partial-Home-State-Cover) irrespective of whether recovery is actually made in respect of such liability.

indemnity period

means:

- i. in the SRA Indemnity Insurance Rules and the *MTC*, the period of one year starting on 1 September 2000, 2001 or 2002, the period of 13 calendar months starting on 1 September 2003, or the period of one year starting on 1 October in any subsequent calendar year
- ii. in the SRA Indemnity Fund Rules, the period of one year commencing on 1 September in any calendar year from 1987 to 2002 inclusive, the period of 13 calendar months commencing on 1 September 2003, and the period of one year commencing on 1 October in any subsequent calendar year.
